The appellant Sri Harinarayan Pathak is present.

Sri Seng Timung, Deputy Secretary and SPIO, Industries & Commerce Department, Government of Assam is present.

Seen the order of the Commission dated 15.07.2019 in case no. SIC/KP(M).777/2019. The operative part of the order is as follows-

"The Commission hereby orders that the SPIO, Industries & Commerce Department, Government of Assam shall furnish the informations to the appellant, free of cost, within 15 days of receipt of the order."

The SPIO did not comply with the order of the Commission, and as such the appellant submitted a complaint petition dated 16.12.2019 which was received by the Commission on 19.12.2019. The SPIO, Industries & Commerce Department, Government of Assam has given written statement stating that the RTI petition of Sri Harinarayan Pathak dated 28.09.2018 cannot be traced out for which he is unable to furnish the sought for informations.

The Commission orders the SPIO, Industries & Commerce Department, Government of Assam to furnish the sought for informations within 7 days of receipt of this order. If further complaint is received from the appellant it will invite invocation of Section 20(1) of the RTI Act, 2005 for imposition of penalty.

The complaint is disposed of.
