O R D E R

The appellant Sri Abdul Kadir Choudhury is present.

The SPIO, o/o the BDO, Algapur Dev. Block is absent without step.

Seen the case record. The appellant submitted one petition under the provision of RTI Act, 2005 dated 07.07.2020 before the BDO, Algapur Dev. Block seeking certain informations. He did not receive the sought for informations within the stipulated period and as such, submitted 1st appeal dated 21.08.2020 before the Project Director, DRDA, Hailakandi and the 1st Appellate Authority. The FAA admitted 1st appeal and fixed date of hearing on 22.09.2020 and issued notices to the BDO, Algapur Dev. Block and the petitioner Sri Abdul Kadir Choudhury. On the date of hearing i.e. on 22.09.2020, the FAA passed order directing the BDO to furnish the informations to the petitioner which are available in hard copies within 03.10.2020. However, the SPIO, Algapur Dev. Block did not furnish the informations to the petitioner even after receipt of directions from the FAA and hence, the appellant submitted 2nd appeal dated 20.10.2020 before the Commission which was received on 04.11.2020. The Commission admitted the 2nd appeal and issued notices fixing date of hearing where the SPIO/BDO, Algapur Dev. Block is absent. Since, the PD, DRDA, Hailakandi has ordered to furnish the sought for informations that means none of the informations is exempted u/s 8(i)(j) of the RTI Act, 2005. **Therefore, the SPIO/BDO, Algapur Dev. Block is directed to furnish the informations to the appellant within 10 days of receipt of this order.**

The 2nd appeal is disposed of. However, the appellant is at liberty to move this Commission, if the said order is not complied with. Non-compliance of the order will invite invocation of section 20(1) of the RTI Act, 2005 for imposition of penalty.
