- 1. The appellant Shri Joydeb Das is present.

- 3. From perusal of records it is seen that the appellant Sri Joydeb Das had submitted an RTI application to the SPIO, Assam Seeds Corporation. Ltd. is hereby reminded not to waste valuable time of the Commission as well as of the organization, which he has done by way of not submitting a written statement as directed in the Commission's notice No. SIC/KP(M).208/2020/11 dated 23.12.2020. He is also directed to submit a written statement whenever called for, so that valuable time of the Commission and Organisation does not get wasted.
- 7. With the above order the Second Appeal is hereby disposed of.
