<u>O R D E R</u> 22-01-2021

- 1. The appellant Shri Balen Kalita is present.
- 2. Shri H.S Medhi, SPIO, GMDA is present. He has also submitted a written statement No. GMDA/RTI/2020/26/11 dated 22.01.2021, with which he has submitted an Action Taken Report on the RTI application of the appellant. He has also submitted copy of letter No. GMDA/RTI/2020/26/10 dated 19.01.2021 written to the appellant regarding furnishing of information. According to this letter the relevant file which the appellant has sought in his RTI application is yet to be traced out and that information will be provided as and when the file is traced out. Regarding point No. (ii) of the RTI application, information has been already provided to the appellant.
- 3. The SPIO, GMDA is directed to take all necessary steps to trace out the relevant file and provide the information at the earliest. He is also directed to inform the appellant as well as the Commission within 30 days from the receipt of this order about the status of the effort to trace out the relevant file and/or also inform the appellant and the Commission about the next steps to be taken in the event of non-traceability of the file after one month.
- 4. With the above order the Second Appeal is hereby disposed of.
