- 1. The appellant Shri Durgeswar Das is absent without any intimation.
- 2. The SPIO/ADC, Smti Debahuti Bora is present. She has also carried letter No.NRF 01/2010/244 dated 16.01.2021, being an authority letter by the Deputy Commissioner, Nagaon, to attend the hearing. She had earlier also sent a written statement No. NDC(RTI Cell)03/2020/05 dated 11.01.2021, informing the Commission that while the FAA had twice fixed hearing on the appeal of the appellant on 12.07.2019 and 17.07.2019, the appellant was absent on both dates without any intimation.
