The SPIO has also submitted copy of letter No. C.I. 207/2019/45 dated 08.01.2021 addressed to the appellant. According to the letter, none of the information sought for by the appellant are available with the Public Authority.
- 3. From perusal of records it is seen that the appellant Shri Harinarayan Pathak had, through his RTI application dated 18.04.2020, sought the following: (1) Copy of Annual Administrative Report of the Department of Industries and Commerce, Govt. of Assam from 1997 to 2020, (2) Copy of Notification in Extraordinary Gazette of Assam related to (a) 11.12.1997, (b) 11.08.2000, (c) 03.03.2001 and (d) 04.06.2005, and (3) Copy of certain file notings of 1997 and 2005.
- 4. The appellant however stated during the hearing that the SPIO has assured him to provide him the informations as and when available. The SPIO too stated the same.
- 5. In view of the above, the SPIO is directed to make all efforts to provide the information sought whenever available, and inform the Commission accordingly.
- 6. With the above order, the Second Appeal is hereby disposed of.
