O R D E R 12-01-2021

- The appellant Sri Durgeswar Das is absent. But he has sent a letter to the Commission by e-mail dated 10.01.2021, informing that he has received the information sought for from the Head Master, 618 No. Talibor L.P. School, Dhing, Dist- Nagaon, PIN-782123, on 10.01.2021, and has requested to drop the case.
- 2. The SPIO, O/o the Head Master, 618 No. Talibor L.P. School, Dhing, Talibor Sonarigaon, W.No-2, Dist- Nagaon, PIN-782123, is absent. But the Head Master has sent a mail to the Commission on 12.01.2021, informing that the informations sought for by the appellant Sri Durgeswar Das has been furnished to him on 10.01.2021.
- 3. From perusal of records it is seen that the appellant Sri Durgeswar Das had submitted his RTI application to the SPIO, O/o the Head Master, 618 No. Talibor L.P. School, P.O- Dhing, on 24.12.2018, and had submitted his First Appeal before the First Appellate Authority, Office of the Block Elementary Education Officer, Batadrava Education Block, on 31.01.2019. On not getting any response, the appellant submitted an appeal before this Commission on 20.03.2019. While the Commission fixed 12.01.2021 as the date of hearing in the matter and accordingly sent notices to the parties on 16.12.2020, the appellant and the Headmaster of 618 No. Talibor L.P. School have both separately informed the Commission on 10.01.2021 (i.e, two days before the date of hearing) that the information has been furnished on 10.01.2021. The letter of the Head Master of 618 No. Talibor L.P. School, written on plain paper with a seal at the bottom without any official reference number, states that the Head Master could not find time to respond to the RTI application dated 24.12.2018 as he was "busy in specific departmental (government) work" including Gunotsav. The Head Master is reminded that responding to an RTI application is equally important, if not more, as other Government work. The Commission has failed to understand why and how the Head Master found time to respond to the RTI matter only after being served a notice from the Commission.
