ORDER 12-01-2021

- 1. The appellant Shri Durgeswar Das is absent. But he has informed the Commission by e-mail that he has received the informations from the SPIO, O/o the Bhugai Bayan Balika Bidyalaya, Namdumdumia Satra, Dhing, Dist-Nagaon, on 10.01.2021, and has requested for dropping the case.
- 2. The SPIO, O/o the Bhugai Bayan Balika Bidyalaya, Namdumdumia Satra, P.O. & P.S.- Dhing, Dist-Nagaon, is absent without any intimation.
- 3. On enquiry the Block Elementary Education Officer, Batradrava Education Block, Dhing, Dist- Nagaon, has informed the Commission over the telephone that the Bhugai Bayan Balika Bidyalaya, has been closed down in 2019 and merged with another school as there were very few students enrolled in it.
- 4. Since the appellant Shri Durgeswar Das has in his letter e-mailed to the Commission claimed that he has received the informations from the SPIO. O/o the Bhugai Bayan Balika Bidyalaya, which according to the BEEO, Batadrava, has ceased to exist from 2019, as such BEEO, Batadrava Education Block, Dhing, Dist. Nagaon, is directed to enquire into the matter and submit a report to the Commission within 15 (fifteen) days from the receipt of this order. The appellant Shri Durgeswar Das is also directed to clarify, within 15 days from the receipt of this order, as to exactly from whom (name by person and designation) he has received the informations sought for, when the said Bhugai Bayan Balika Bidyalaya, has been closed down in 2019 itself.
- 5. Send a copy of this order to the Deputy Commissioner, Nagaon, for information.
- The case will be finally disposed of only after receipt of the report from the BEEO,
 Batadrava Education Block, Dist. Nagaon and a reply from the appellant Shri
 Durgeswar Das.
