<u>O R D E R</u> 07-01-2021

He/She is also directed to submit a written statement mentioning the date of receipt of the RTI application by him/her and the date of furnishing the sought for information to the RTI applicant, if he/she has already furnished the information. If not, his/her written statement should also explain why penalty under Section 20(1) of the RTI Act. 2005, shall not be imposed on him/her for his/her failure to furnish the sought for information within the stipulated time period. If the request for information was rejected under Section 7(1), then his/her written statement may indicate the date of receipt of the RTI application, and date of rejection by him/her giving reasons for such rejection.
- 6. This order shall constitute notice of hearing.
