O R D E R
15.02.2021

1. The petitioner Sri Joydeb Das is present. The public authority i.e. the SPIO of Gauhati University Dr. Prasanta Barman, Deputy Registrar is present. The PIO & Deputy Registrar of Gauhati University has submitted written statement dated 13.02.2021 which is entered into the case records.

2. On perusal of the case records, it is seen that the petitioner Sri Joydeb Das filed RTI petition dated 2.1.2021 before the PIO of Gauhati University seeking the following information:-

I. Whether any official communication was made with Govt. Auditor till date for submission of Audit Report from 2015 to 2017-18, if yes, please furnish copy/copies of the same along with copy of file notings.

3. Then the PIO of Gauhati University furnished information to the petitioner vide letter NO. GU/PIO/RTI/2020/206 dated 22.12.2020 is as follows:-

(a) The Gauhati University Audit is over up to 2017-18. However, Audit Report has not yet been submitted by Govt. Auditor. Hence, we cannot furnish the same

4. It is mentioned in the written statement that the Deputy Treasury has written a letter dated 12.1.2021 to the Director, Local Fund Audit, Govt. of Assam to furnish the Audit report from 2015 to 2017-18.

5. The petitioner says that he has not received the copy of letter dated 12.2.2021 written to him by the PIO of Gauhati University. He has also stated that the reply written to the by the Deputy Registrar of Gauhati University does not mention the date on which the Audit was conducted and whether there was any delay in receipt of the Audit Report.

6. The Commission therefore, directs the PIO of Gauhati University to intimate the petitioner the date on which Audit for the period from 2015 to 2017-18 was conducted. The PIO of Gauhati University is also directed to furnish a copy of letter dated 12.2.2021 to the petitioner.

7. The second appeal petition dated 6.2.2021 is conditionally disposed off.
