## ORDER

23.04.2021

- 1. The petitioner Sri Rudra Kanta Mahanta is absent.
- 2. On perusal of the case records, it is seen that the petitioner filed RTI petition dated 8.7.2020 before the SPIO, O/o the Inspector of Schools, Karbi Anglong Autonomous Council seeking the following information:-
  - (i) Whether your authority had given permission to the head master of deopani high school to hold a meeting on dated 21/11/2019 and 31/12/2019 by avoiding teaching to the students. If so kindly send a copy of your said order of the permission.
  - (ii) Whether the president of the school management committee has a right to wind up the teaching of the teachers to the students on particular day on special reason. If so kindly provide such order copy of the government.
- 3. Reportedly the petitioner filed first appeal petition dated 10.9.2020 for not getting any information. Then the petitioner filed second appeal petition dated 01.12.2020 before the Commission. Accordingly the date of hearing was fixed today.
- 4. The petitioner Sri Rudra Kanta Mahanta has sent letter dated 22.4.2021 stating that due to some unavoidable circumstances he is not able to remain present in today's hearing. He has also mentioned that he has received the reply from the Inspector of Schools, Diphu and raised the objection stating that the reply is not specific.
- 5. Mrs. Gayatri Naiding, Inspector of Schools, Karbi Anglong, Diphu is present. She has also submitted a written statement before the Commission vide letter No. IS/KADC/RTI Act/8575 dated 22.4.2021. It is mentioned in the written statement that the information has already been furnished to the RTI petitioner.
- 6. On perusal of both the objection raised by the petitioner as well as the reply submitted by the Inspector of Schools, Karbi Anglong, the Commission feels that information is in compliance to the RTI petition and hence decides to dispose the second appeal petition dated 1.12.2020. Mark authenticated copies to all concerned.
