O R D E R 24-3-2021

The appellant Shri Bhupati Kalita is absent without any intimation. The Joint Secretary BTC Kokrajhar has authorized Shri Uday Kumar Basumatary i/c Joint Director cum CHD, Fishery Department, BTC to attend today's hearing. Accordingly, Shri Uday Kumar Basumatary is present.

Shri Uday Kumar Basumatary submitted one letter bearing no. JDF/BTC/73/2020-21/780 dated 19/3/2021 addressed to the Secretary, Fishery Deptt. BTC informing that information sought for by the appellant Shri Bhupati Kalita is not available in his office. Information in receipt of implementation of NFDB (National Fishery Development Board) Scheme is not available with his office.

It is observed that the SPIO of Fishery Department,BTC, has failed to furnish the information as ordered by the Commission vide its order dated 27.8.2019 for which fresh hearing is required to be taken on receipt of complaint from the appellant Shri Bhupati Kalita.

The i/c Joint Director cum CHD, Fishery Department, BTC Kokrajhar who has been deputed by the Fishery Department BTC informs the Commission that his office is knowhow related with implementation of NFTB Scheme in BTC area.

Therefore, the Commission directs the SPIO of Fishery Department, BTC to furnish the sought for information to the appellant within 7 days of receipt of the order.

The Principal Secretary, BTC, being the Controlling Officer is directed to ensure that the order is complied with.

Non compliance of the Commission order will invite Section 20 of the RTI Act, 2005.

The Complaint petition dated 31.10.2019 is disposed off.
