ORDER

15.03.2021

- 1. The Petitioner Sri Rupjyoti Das is present. The public authority to be represented by the SPIO of the Deputy Commissioner, Kamrup, Amingaon and the Addl. Deputy Commissioner & i/c Land Revenue Branch of the Office of the Deputy Commissioner, Kamrup, Amingaon are absent without any intimation.
- 2. On perusal of the case records, it is seen that the petitioner filed RTI petition dated 19.10.2020 before the Deputy Commissioner, Kamrup, Amingaon seeking information regarding sale permission of land bearing Patta No. 65 Dag No. 239.
- 3. On non getting any information the petitioner filed first appeal petition dated 19.11.2020 before the First Appellate Authority i.e. the Deputy Commissioner, Kamrup, Amingaon. The First Appellate Authority i.e. the Deputy Commissioner, Kamrup, Amingaon vide order dated 21.12.2020 directed the Addl Deputy Commissioner, Kamrup, i/c Land Revenue Branch, Kamrup to furnish the necessary information directly to the appellant as sought for by him within 7 (seven) days.
- Reportedly as the petitioner has not received any reply even after the order of the First Appellate Authority, he filed second appeal petition dated 8.1.2021 before the Commission. Accordingly the hearing was fixed today i.e. 15.3.2021.
- The SPIO, O/o the Deputy Commissioner, Kamrup, Amingaon is absent. He has neither sent any intimation on his absence nor sent any written statement.
- 6. This is a fit case to impose penalty for non submission of information. The Commissioner therefore issues show cause notice to the SPIO of the Office of the DC, Kamrup, Amingaon and also issues notice to the Addl, Deputy Commissioner, Kamrup, Amingaon, i/c Land Revenue Branch, Kamrup to remain present at the next date of hearing.
- 7. Fix another date of hearing after election.
