ORDER 23/04/2021

- 1. The appellant Sri Mintu Saikia has filed an RTI application on 14/12/2020 seeking following information:-
  - (a) Accident occurred on 25<sup>th</sup> July,2020 at around 6 PM in the place of Majgaon (Tezpur) under the jurisdiction of Mahavairob Outpost under Tezpur Police Station being victim name Dilip Das on his motorcycle bearing Registration No. AS-01-DP-4986 and in between a Dumper.
  - (b) In this regard seeking description of information:
    - (i) GD Entry No., If any under Mahavairob Outpost under Tezpur Police Station.
    - (ii) Case No., If registered, under Mahavairob Outpost under Tezpur Police Station.
    - (iii) Form 54 may kindly be furnish in connection with the aforesaid case.
- 2. Reportedly on not getting any information, he filed 1<sup>st</sup> appeal before the First Appellate Authority on 9/2/2021 and then he filed 2<sup>nd</sup> appeal before the Commission on 12/3/2021. Accordingly hearing was fixed today.
- 3. The petitioner Sri Mintu Saikia is present.
- 4. The Public Authority to be represented by SPIO of the Office of Superintendent of Police, Sonitpur is absent. However, Superintendent of Police, Tezpur has filed a written statement dated 13/4/2021 which is taken into records.
- 5. In the written statement, he has mentioned that the required information has already been furnished and as the CD of Tezpur Case No.1290/2020 is sent to Honourable Gauhati High Court, some documents which are with the CD cannot be furnished to the petitioner.
- 6. The petitioner intimates that duplicate copy of Form 54 is yet to be furnished by the SPIO. Since the SPIO has already mentioned about the dispatch of the CD and non-availability of the same under his jurisdiction, he is not in position to furnish the information.
- 7. In view of the above, the instant 2<sup>nd</sup> appeal petition dated 12/3/2021 is disposed off
