O R D E R 23/04/2021

- 1. The petitioner Smti Dipti Dey is absent. However, she has sent an email dated 21.4.2021 wherein she has mentioned that due to Covid-19 situation she is not in a position to come to Guwahati.
- 2. The Public Authority to be represented by SPIO of the Office of Elementary Education Department, Dispur is absent. However, SPIO of the Office of Elementary Education has filed a written statement vide no. AEE(RTI) 1/2020/45 dated 22nd April 2021 stating as follows:-
 - (a) That their Department has not received any application in respect of Smti Dipti Dey of Hailakandi.
 - (b) While receiving 1st appeal u/s 19(1), the same was forwarded to the First Appellate Authority, Office of the District Elementary Education Officer, Hailakandi, Dist.- Hailakandi, Assam for disposal of the 1st Appeal and furnish information directly to the appellant vide letter no. AEE(RTI)6/2019/73 dated 22.2.2021.
- 3. The Commission therefore directs the SPIO, Elementary Education Department Dispur to collect the relevant information and furnish the same to the RTI petitioner if not already furnished with intimation to this Registry within 1 month from the date of receipt of this order.
