- 6. Issue notice with copy to earlier order to the SPIO i.e.,In-Charge, Srikona Patrol Post, Silchar, C/O Banwar Lal Mina, S.P. Cachar asking him to explain within 15 days from the receipt of this letter why no penalty u/s 20 of the RTI Act to be imposed on him.
