O R D E R
07/04/2021

1. The petitioner Sri Vijay Pandey is absent. But he has sent an email dated 6.4.2021 informing about his inability to attend the hearing due to illness and has requested to re fix the date of hearing, but he has failed to send any medical report on his illness.
2. The SPIO, Officer i/c, Dibrugarh Police Station is also absent . However, Sri Rajib Kumar Saikia, Inspector of Police, Officer i/c of Dibrugarh Police Station has submitted a written statement dated 7/4/2021 wherein he has mentioned that he has not been designated as SPIO of Dibrugarh PS. Hence he is not authorised to receive any RTI petition, for which he has returned the RTI application to the RTI petitioner.
3. The Commission accepts the prayer and disposes off the case.
However, as per Section 5(1) RTI Act,2005 *Quote* Every public authority shall within one hundred days of the enactment of this Act, designate as many officers as the Central Public Information Officers or State Public Information Officers, as the case may be, in all administrative units or offices under it as may be necessary to provide information to persons requesting for the information under this Act. *Unquote*
4. The Superintendent of Police, Dibrugarh is therefore directed to either notify the SPIOs at Police Station levels or publicize that SPIO for Dibrugarh district Police Stations will be the SPIO of Superintendent of Police, Dibrugarh.
