	<u>O R D E R</u> 3/3/2021

- 1. The appellant Mr. Foriz Uddin Laskar has filed a RTI petition dated 4.6.2020 seeking following information:-
  - (i) Photocopy of the list of casual worker of Hailakandi District (A.P.G.P.Z.P) including the order copy of engagement and joining report of all Casual workers for the year 1992 to 2019 along with the verification report received from D.O's and CEO's Z.P. Hailakandi time to time including list.
  - (ii) Photocopy of all the communication letter's & corresponding letter's of all for the year 1992 to 2020.
  - (iii) Photocopy of the circular of regularisation for the year 1992 to 2020.
- Reportedly on not getting any information, the appellant filed 1<sup>st</sup> appeal before the 1<sup>st</sup> Appellate Authority of Commissioner of Panchayat & Rural Development, Panjabari Guwahati on 10.9.2020.
- 3. On not getting any response from the 1<sup>st</sup> Appellate Authority, he filed 2<sup>nd</sup> appeal before the Commission on 9.11.2020.
- Accordingly notice was issued vide letter no.SIC/HLK.60/2020/6 dated 29.12.2020 to all the concerned for hearing of the case on 22.1.2021 at 12:00 P.M.
- 5. On 22.1.2021, the appellant Mr. Foriz Uddin Laskar was present and he has intimated verbally that he has not received any information from SPIO and First Appellate Authority.
- 6. The SPIO of the Office of Commissioner, P & RD was absent on 22.1.2021 without any intimation and accordingly on 22.1.2021 the Commission had decided to fix another date of hearing and directed both SPIO and petitioner to remain present.
- On 3.3.2021, Sri Ajit Baruah, Joint Director & SPIO, O/o the Commissionerate of P & RD was present and he has filed a written statement which is taken into records.

In the written statement he has prayed before the Commission to condone the delay in submission of information due to Covid and various other issues.

- 8. However, the appellant Mr. Foriz Uddin Laskar has sent an email which is received on 2.3.2021 at 4:20 P.M wherein he has mentioned that no information has been provided to him and he has prayed before the Commission to do the needful as per the provision of law.
- 9. However, Mr. S.A.Laskar, Joint Director, O/o the Commissioner, P& RD vide his letter dated 16<sup>th</sup> February,2021 has intimated that Chief Executive Officer, Hailakandi Zilla Parishad vide letter no. HZP.738/RTI/Ot.II/2014-15 dated 4.1.2021 has submitted the required information to Mr. Foriz Uddin Laskar, who has received the same on 4.1.2021 but he has concealed the fact on 1<sup>st</sup> hearing held on 22.1.2021 and he is also misleading the Commission.

- 10. This is a serious offence on the part of the RTI applicant as he has made false statement against the SPIO, misled the Commission and wasted the time of the Commission.
- 11. In light of it, the Commission decides to debar him from filing 2<sup>nd</sup> appeal petition for one (1) year.

The appellant may file his representation, if any, in this regard within 15 days from the date of receipt of this order.
