## ORDER

03.08.2021

- 1. The petitioner Sri Bhaskar Jyoti Das filed RTI petition dated 11.1.2021 before the SPIO of the Directorate of Social Welfare seeking following information:
  - (i) Whether there is any Central Govt. scheme as SNP (Supplementary Nutrition Programme) going on in Assam by the State Social Welfare Department.
  - (ii) What kind of the works or programme carried under this SNP Scheme?
  - (iii) Kindly inform the total fund allocated to the state of Assam under the SNP Scheme in financial year 2011-12, 2012-13, 2013-14, 2015-16, 2016-17, 2017-18, 2018-19, 2019-20 and 2020-21.
  - (iv) Kindly inform the total number of Anganbadi Centres and Mini Anganbari Centres functioning till 30.05.2020 as per district wise list. Kindly furnish a copy of the same list.
  - (v) Kindly inform the total number of beneficiaries of SNP Scheme of Central Govt. (Child mother and pregnant women) in Assam. Kindly furnish district wise list of beneficiaries.
- 2. Then the petitioner filed first appeal petition dated 16.2.2021 before the First Appellate Authority of Directorate of Social Welfare and then the petitioner filed second appeal petition dated 23.3.2021 before the Commission. Accordingly the hearing is fixed toady.
- 3. The petitioner Sri Bhaskar Jyoti Das is present. The public authority i.e. the SPIO of the Directorate of Social Welfare Sri Samir Das, Deputy Director is present. The petitioner has stated that he has filed two RTI applications on that day but in his second appeal he has enclosed only one application, so the second appeal petition is taken up for hearing only.
- 4. The petitioner mentioned that he has received information in respect of point Nos. 2, 3 and 4 of his RTI petition and as regards to point No 3, he has received a part of the information i.e. from 2016-17 onwards.
- 5. The SPIO intimated that the files relating to the part information of point no. 3 as required by the petitioner is seized by the Vigilance Department and they are not in a position to furnish that information.
- 6. However, as regards point No. 5 of the RTI petition, the SPIO brought the compiled list and the Registry of this Commission is directed to give a copy of the compiled list to the petitioner.
- 7. In light of it, the second appeal petition dated 23.3.2021 is disposed off.
