O R D E R

27.07.2021

1. The petitioner Sri Joydeb Das is present. The public authority i.e. the SPIO of the Office of the District Commandant of Home Guard Sri Basanta Sarma is present.
2. On perusal of the case records, it is seen that the petitioner Sri Joydeb Das has filed his RTI petition dated 8.3.2021 before the PIO of District Commandant, Home Guard, H.Q seeking following information:
 - (i) Please furnish a copy of NCC-C certificate of Sri Basanta Sarma, District Commandant, Home Guard, H.Q. Panikhaiti, Assam-26.
 - (ii) Please furnish in details the place, year and unit where NCC camp was held, along with name of the unit officer.
 - (iii) Please furnish in details name of the some others NCC candidate who attend the camp with Sri Basanta Sarma.
3. Being aggrieved by not getting any information, the petitioner filed first appeal petition dated 19.4.2021 before the First Appellate Authority of Home Guard, HQ. Then the petitioner filed second appeal petition dated 14.6.2021 before the Commission.
4. In the mean time as intimated by both the petitioner and the SPIO the reply to the RTI petition has already been furnished to the petitioner vide letter No. KHG.2/2020-21/50 dated 24.5.2021 and the reply is as follows:
 - (i) Lost NCC-C Certificate.
 - (ii) Not remember.
 - (iii) Not remember.
5. The appellant stated that he has not received proper reply as regards to point No 1, 2 and 3 of the RTI petition and therefore he is not satisfied with the reply.
6. The SPIO Sri Basanta Sarma stated that he has lost his NCC-C certificate along with other documents and he can furnish a copy of police report to this effect. As regards point 2 and 3 he did not remember. He further stated that the appellant may apply to NCC Headquarters and other offices for getting a copy of NCC-C certificate.
7. The appellant stated that the reply was specifically asked from the SPIO and he is not at all satisfied with the reply.
8. In light of it, the second appeal petition dated 14.6.2021 is disposed off at the Assam Information Commission.
