**O R D E R**

27.07.2021

1. The petitioner Sri Manoj Das is present. The SPIO of Director of State Council of Education Research & Training (SCERT) Dr. Sumona Roy, Joint Director and Sri Hemanta Narayan Das, Documentation Officer are present.
2. On perusal of the case records, it is seen that the petitioner Sri Manoj Das has filed RTI petition dated 5.1.2021 before the SPIO of Directorate of SCERT seeking the following information:
  - I. Specify in details, Amount of Fund allotment and Cilling received by your office under Central Sponsored Scheme, State Share and how were this fund Utilized.
  - II. What are the training conducted all over Assam under the head "Teacher Training"
    - (i) Nos. of Training
    - (ii) Nos of Trainees and
    - (iii) Mode of Training.
  - III. Specify in details, amount of Fund Received under Infrastructure Development and how were this fund spend Institutional wise in Assam for B.ed, DLed, Normal School, in BTC, Ect.
  - IV. Specify in details, Where is the fund deposited, DCR account or Current account that received from Central and State Govt. if deposited in Current Account, permission from Finance Department obtain or not.
3. The SPIO and Documentation Officer stated that they have already furnished part information and as regards to the total numbers of Training and total numbers of Trainees, the SPIO has already directed the all Principals of IASE. CTEs & DIETs of Assam to furnish the information. However, a figure of ten (10) units is already available with them and they have issued reminders to furnish the information at an early date.
4. The Commission therefore, directs the SPIO to collect the information of total number of training/programmes and total number of trainees and furnish the information to the petitioner within one month from the date of receipt of this order.
5. With the above direction, the second appeal petition dated 31.3.2021 is disposed off.
