ORDER 27.07.2021

- 1. The petitioner Sri Joydeb Das is present. The SPIO of Director of State Council of Education Research & Training (SCERT) Dr. Sumona Roy, Joint Director and Sri Hemanta Narayan Das, Documentation Officer are present.
- 2. In pursuance to this Commission's earlier order dated 08.07.2021, it is seen that the reply of the SPIO was not specific. The SPIO of SCERT had only furnished partial information stating that the documents are voluminous and it will take more time to transfer the information into digital mode. The SPIO further stated it will be better if the petitioner can come to the Directorate of SCERT and inspect the documents and in his presence the specific documents which are required by him will be scanned or photocopied and furnish to him.
- 3. Though the time for SPIO to furnish the information is already over, still taking a lenient view the Commission directs the SPIO to find a convenient time in discussion with the petitioner and furnish the specific reply within one month from the date of receipt of this order.
- 4. With the above direction, the second appeal dated 20.4.2021 is disposed off.
