O R D E R

1. The petitioner Sri Kishor Bez has filed RTI petition dated 12.11.2020 seeking three queries related to District Agriculture Officer, Nalbari before the SPIO of the Directorate of Agriculture.
 2. Reportedly on not getting information the petitioner filed first appeal petition dated 1.2.2021, the petitioner again submitted a reminder vide letter dated 19.2.2021 to the SPIO of the Directorate of Agriculture to furnish the information. Then the petitioner filed second appeal petition dated 8.3.2021 before the Commission. Accordingly, the hearing is fixed today.
 3. The petitioner Sri Kishor Bez is absent. However, his mobile is not reachable and the Commission's notice dated 14.7.2021 issued to him could not be delivered with the remark on envelop as 'out of station'. In the mean time, the SPIO Mr. Madhuram Patiri, District Agriculture Officer, Nalbari to whom the RTI petition was forwarded is present and he has furnished his reply in connection with the RTI petition vide letter No. DAO(N)/RTI/2020-218/668-70 dated 26.7.2021, a copy of which is also marked to this Commission. He has also brought three to four voluminous files stating that the information is available which may given to the appellant. Therefore, the Commission directs the SPIO to fix a convenient to call the appellant for inspection of documents and the appellant is also directed to appear and collect only relevant documents as per the RTI Act, 2005.
1. In light of it the second appeal petition dated 8.3.2021 is disposed off.
