O R D E R 29/07/2021

- 1. The petitioner Sri Arnab Jan Deka is present. The petitioner has filed his RTI petition on 8/10/2020 seeking seven (7) nos. of queries.
- 2. Being aggrieved with the information received from GMC, the appellant filed 1st appeal on 3/12.2020.
- 3. The petitioner filed 2nd appeal petition before the Commission on 26/4/2021 and accordingly hearing was fixed today.
- 4. The Public Authority is represented by Rajib Neog, Associate Planner & Deemed PIO and he is accompanied by Kapil Dev Choudhury, Zonal Engineer, GMC. The PIO of GMC has submitted a written statement no.GMC/RTI/FAA/34/2020/44 dated 28/7/2020 which is taken into records.
- 5. The appellant has intimated that he has received only part information (unsigned and uncertified).
- 6. The Associate Planner has verbally intimated that certain information relating to RTI petition has already been furnished to the petitioner, but some information sought by the petitioner is third party and to furnish the information they have to take permission from third party.
- 7. In the meantime, the appellant has pointed out that he has received proper map from GMDA, whereas GMC has provided him only one small portion of the map.
- 8. Therefore the Commission directs the SPIO to provide the information as per RTI application and whichever is not be given as per the provision of the RTI Act, the same should be specifically mentioned.
- 9. The information to be given within 15 days from the date of receipt of this order.
- 10. In view of the above, the instant 2nd appeal petition dated 26/4/2021 is disposed off.
