**O R D E R**  
**08/07/2021**

1. The petitioner Sri Joydeb Das is present. The petitioner filed his RTI application on 22.12.2020 seeking information on fund managed by the Directorate of Students Welfare, Gauhati University.
2. The Public Authority is represented by Dr. Ranjan Kumar Kakoti, Director, Students Welfare, Gauhati University.
3. Accordingly, office of the Registrar, Gauhati University, has intimated to the appellant vide letter no. GU/PIO/RTI/2021/207 dated 1/2/2021 that there is no such fund maintained at the Directorate of Social Welfare, Gauhati University.
4. Though the appellant has mentioned that he has not received copy of this letter, the Director, Students Welfare has produced a copy of the letter to the Commission and copy of the same is given to the appellant.
5. The appellant also submitted an exhibit i.e., Gauhati University 9<sup>th</sup> meeting of Executive Council dated 19.11.2019.
6. On perusal and as pointed by the Director of Students Welfare, the same relates to the Welfare fund of the Vice Chancellor, not about the so called welfare fund maintained at the Directorate of Students Welfare.
7. Hence, the Director, Students Welfare has pointed out that he is not connected with the fund maintained by the Vice Chancellor.
8. The appellant was accordingly intimated about it and was advised if he so desire to pursue the case, by filing another RTI petition.
9. In view of the above, the case is disposed off.
