ORDER 28/07/2021

- 1. The petitioner Sri Hara Kanta Bora is present. He has filed RTI petition on 12/8/2020 seeking following information:-
 - (a) Copy of the L/No. KRS-123/2013/1886, Dated 18/3/2015, along with the list of applicants enclosed with the letter
 - (b) Date of despatch of the letter.
 - (c) Date of received of the letter at the Dispur Revenue Circle i.e., date of delivery of the letter.
 - (d) Name of the applicants whose files have been processed by the Dispur Revenue Circle in response to the above letter for settlement.
 - (e) Copy of the corresponding letters in this regards (for ready reference one of such letters No. is KRS-874/2000/2677 dated 31/10/2019) along with the reports so submitted against each of the applicants by the Dispur Revenue Circle.
 - (f) Kindly mention whether the files of Sri Kamala Kanta Deka, Srikanta Mazumdar and Tusheswar Tai have been sent to the Revenue Branch(land settlement branch) of the O/o the Deputy Commissioner, Kamrup(M) after due processing in response to your corresponding letters.
 - (g) Kindly provide the name of the applicants forwarded to Govt. for settlement.
 - (h) Kindly provide the copies of the letters sent to Govt. in this regards.
- 2. Reportedly on not getting any information, the petitioner filed 1st appeal before the Deputy Commissioner, Kamrup(M) on 25/9/2020.
- 3. The petitioner filed 2nd appeal before the Commission on 06/04/2021 and accordingly the hearing was fixed today.
- 4. The Public Authority is represented by Sri Kongkon Jyoti Saikia, Assistant Commissioner, Kamrup (Metro). The SPIO has submitted written statement dated 27/7/2021 which is taken into records.
- 5. The SPIO has mentioned that the information has already been provided, however, the appellant has mentioned that though he has received the information but there is some confusion which he has already discussed with the Dealing Assistant and the Dealing Assistant has promised to clear it as per their convenience.
- 6. In light of it, the Commission directs the SPIO to facilitate the clearance of the confusion in furnishing of the information.
- 7. The case is disposed off.
