1. The petitioner Smti Dipali Chatterjee is absent. She has filed her RTI application on 27.2.2020 before the SPIO of the Directorate of Agriculture, Khanapara. On non receipt of any information she filed 1<sup>st</sup> appeal before the First Appellate Authority of Directorate of Agriculture, Khanapara and then she filed 2<sup>nd</sup> appeal before the Commission on 9.2.2021 and accordingly the hearing was taken today.
2. The petitioner has sent an email dated 28.9.2021 wherein it is mentioned that because of her financial problem and ill health she is unable to attend today's hearing. In the mail it is also mentioned that she has not received any sought for information from the Directorate of Agriculture, Khanapara.
3. The Public Authority is represented by Shri Bijoy Chandra Sarma, SPIO, Directorate of Agriculture, Khanapara. The SPIO verbally intimated that the sought for information has been furnished to the petitioner through normal post.
4. **The Commission therefore directs the SPIO to resend the information through speed post today itself (which he did promptly) and copy of the speed post receipt should be submitted to the Registry of the Commission.**
5. In view of the above, the instant 2<sup>nd</sup> appeal petition dated 9.2.2021 is disposed off.
