<u>O R D E R</u> 20/08/2021	

- 1. The petitioner Sri Joydeb Das is absent. However, he has sent an email dated 20.8.2021 wherein he has mentioned that due to his health reason he is unable to attend today's hearing. The petitioner in his mail has also mentioned that he not received any information sought by him.
- 2. The Public Authority is represented by Sri Gunjanan W Shyam, ASPIO, Assam Seeds Corporation.
- 3. The SPIO of the Office of Assam Seeds Corporation Ltd. has submitted a written statement dated 19/8/2021 wherein she has mentioned that the Deemed PIO was not able to furnish the information on time as he was in leave because of an accident for a period of 1 month and joined office on 16th August, 2021. Hence he has requested for 15 days more time to furnish the sought for information.
- 4. The petitioner filed his RTI petition on 12.4.2021 and if Deemed PIO had met with an accident and was on leave for one and half month, roughly from the month of July to August, he was very well present from 12.4.2021 to 30.6.2021.
- 5. As per Section 7 of the RTI Act, 2005 the information should be furnished to the petitioner within 30 days.
- 6. Since the Deemed PIO is not present, the Commission has decided to fix another date of hearing and directs the SPIO to submit an explanation why no action should be taken for failure of furnishing the information within stipulated time period.
- 7. Fix 14.9.2021 at 11:45 AM as the next date of hearing.
