## O R D E R 06/09/2021

- 3. The petitioner has filed his RTI application dated 30.01.2021 seeking following information:

    - Letter No. CI.383/97/19, Dated 6.2.1998 as received by the Director of Industries, Assam issued from the Industries Department, Govt.of Assam, Dispur; and,
    - Letter No. DI(V).72/97/164/5150, Dated 3.4.1998 issued from the Director of Industries, Guwahati 781021.
  - (b) Action taken report supported by Documentary Proofs including respective File Notings, in respect of the Public Document as referred to at the query no.(1)(a) above.
- 4. The SPIO of the Commissioner of Industries & Commerce, Assam, Udyog Bhawan, Bamunimaidam, Guwahati 21 has submitted a written statement vide letter no. CI&C(I)80/RTI/2020/73/13,928 dated 3.9.2021 which is taken into records.
- 5. The SPIO of Commissioner of I&C, Bamunimaidam vide his letter no. CI&C (I) 80/RTI/2020/56/11,192 dated 1.4.2021 stated that the documents relate to the year 1998 and inspite of their best efforts they could not trace them out.
- 6. The 1<sup>st</sup> Appellate Authority vide his letter dated 28.7.2021 has stated about the same thing.
- 7. The Commission agrees with the reply and the instant 2<sup>nd</sup> appeal petition dated 26.6.2021 is disposed off.
