## O R D E R 14/09/2021

- 1. The petitioner Sri Joydeb Das is present.
- 2. In pursuance to Commission earlier order dated 20.8.2021, the hearing was taken today.
- 3. The Public Authority is represented by Sri Prafulla Kumar Brahma, Deemed PIO & I/C Audit Officer, Assam Seeds Corporation Ltd. Khanapara.
- 4. The SPIO of Assam Seeds Corporation Ltd has submitted a written statement vide no. ASC/SV/RTI/2021-22/2740 dated 13.9.2021 wherein it is mentioned that the information is furnished. The appellant has received most of the information except information relating to year 2021-22.
- 5. The explanation of Deemed PIO Sri Prafulla Kumar Brahma was not tenable as the transferred RTI petition was received on 19.4.2021 and then the complete lockdown was from 12 May 2021 to 27 May 2021 which means that the petitioner got enough time to furnish the information from 19.4.2021 to 11.5.2021.
- 6. However, since the reply is given, the Commission does not want to impose any penalty for non furnishing of the information on time.
- 7. In view of the above, the instant 2<sup>nd</sup> appeal petition dated 8.7.2021 is disposed off.
