<u>O R D E R</u> 13/09/2021

- 1. The petitioner Nurul Islam is present.
- 2. The Public Authority to be represented by SPIO of the Office of D C Nagaon (Election Branch) is absent.
- 3. As per the RTI Act, 2005 not only 30 days time is given to the SPIO to furnish the information but also another 30 days time was available to the 1<sup>st</sup> Appellate Authority to furnish the information to the appellant. The RTI application was submitted on 8.9.2020 that means more than 1 year has elapsed.
- 4. In the last hearing, the SPIO was absent and accordingly it was fixed for another date i.e., today.
- 5. The Deputy Commissioner vide his letter no. NE 11/2015/427 dated 10/09/2021 has mentioned that the Election Officer is on leave and requested before the Commission to fix another date of hearing.
- 6. The Commission agrees with the written request of the D C, Nagaon and fixes another date of hearing.

At the same time desires to know why penalty u/s 20 should not be imposed on the PIO/Deemed PIO for the delay in furnishing the information.

- 7. The Election Officer (Deemed PIO) should personally be present on the next date of hearing and submit an affidavit why no penalty to be imposed on him as per the Act.
- 8. Fix 8.10.2021 at 11:30 AM as the next date of hearing.
