## <u>O R D E R</u> 07/09/2021

- 1. The petitioner Miss Jamuna Patar is absent. The petitioner has filed his RTI application dated 7.1.2021 seeking following information:-
  - (a) Copy of GDE No.344 dated 21.11.2020 of Baganpara Police Outpost as well as its all subsequent entry in connection with the said GDE, Particularly the GDE when ASI Lalchan Ali returned from the accidental place with dead body, damage vehicles etc.
  - (b) Copies of seizure lists.
  - (c) Legible copy of FIR.
  - (d) Legible copy of post mortem report
  - (e) Legible copy of MVI report of both vehicles issued by Motor Vehicle Inspector, Baksa District at Mushalpur.
  - (f) Copy of accident information report i.e., Form No.54
  - (g) Legible copy of registration certificate of offending four wheeler vehicle no. AS 14C 9499
  - (h) Legible copy of driving license of the driver of offending four wheeler vehicle No. AS 14C 9499.
  - Legible copy of insurance policy of offending four wheeler vehicle no. AS 14C 9499.
  - (j) Legible copy of fitness certificate of offending four wheeler vehicle no. AS 14C 9499
  - (k) Legible copy of permit certificate of offending four wheeler vehicle no. AS 14C 9499(if any)
  - (I) What is the present status of the said case?
- 2. On not receiving any information, the petitioner filed 1<sup>st</sup> appeal before the !st Appellate Authority cum the Superintendent of Police, Baksa District on 8.3.2021.
- 3. The petitioner then filed 2<sup>nd</sup> appeal before the Commission on 23.4.2021 and accordingly hearing was fixed today.
- 4. The Public Authority is represented by Shri Ujjal Pratim Baruah, Addl. SP(HQ), Baksa.
- 5. The SPIO of the Office of Superintendent of Police, Baksa has submitted a written statement dated 1.9.2021 which is taken into records.
- 6. In the written statement it is mentioned that matter relating to RTI petition of the appellant was taken up with I/C Baganpara OP to furnish the necessary information vide Office memo no. BSA/Crime/RTI/2021/621 dated 5.2.2021. The matter was further pursued with I/C Baganpara OP vide signal no. BSA/Crime/RTI/2021/914 dated 22.2.2021 as the reply for the 1<sup>st</sup> message was not submitted till then.
- 7. And then on receipt of the 1<sup>st</sup> appeal, the matter was taken up with OC, Barbari & I/C, Baganpara OP vide memo no. BSA/Crime/RTI/2021/1317 dated 18.3.2021.
- 8. The OC Barbari PS submitted one report and on the report it was mentioned that they could not submit PM report, MVI report, vehicle document and few other

documents as they were a part of case diary, which is in a way a Hon'ble Courts property.

9. The Commission accepts the written statement and disposes the case.
