1. The petitioner Smti Anusha R has filed RTI petition dated 17.3.2021 before the PIO of Assam State Legal Services Authority seeking seven queries. Reportedly on not getting any information the petitioner filed first appeal petition dated 26.5.2021 before the First Appellate Authority of Assam State Legal Services Authority. On 2.8.2021 the SPIO has sent an email to the petitioner attaching the sought for information. Then the petitioner filed second appeal petition dated 9.8.2021 before the Commission. Accordingly, the date of hearing is fixed today.
