O R D E R

1. The petitioner Sri Pabitra Deka has filed the RTI petition dated 27.4.2021 before the PIO, Commissionerate of Excise. Then the petitioner filed first appeal petition dated 16.6.2021 before the First Appellate Authority of Commissionerate of Excise. Then the petitioner filed second appeal petition dated 13.8.2021 before the Commission mentioning that he has got incomplete information. Accordingly, the date of hearing is fixed today.

2. The petitioner Sri Pabitra Deka is absent on the plea of illness and sent a petition dated 28.9.2021 through email stating that some information is yet to be given. The public authority i.e. the SPIO of the Commissionerate of Excise Sri J.I. Roshid, Superintendent of Excise, Udalguri is present. He has submitted a written statement dated 30.9.2021 which is taken into consideration.

3. In the written statement, the Superintendent of Excise mentioned that the necessary information had already been furnished to the petitioner on time. Since no joining report of Sri Karneswar Das is found in their office, they are not in a position to provide it to the petitioner.

4. In giving a copy of petition dated 28.9.2021 of the RTI petitioner to the Superintendent of Excise, Udalguri and the Commission orders that whatever information is available at their office, the same to be furnished to the petitioner.

With the above direction, the second appeal petition dated 13.8.2021 is disposed off.
