## O R D E R 07.09.2021

- 1. The petitioner Sri Ranjan Roy is absent. The public authority i.e. the SPIO of the Urban Dev. Department Smti Panchami Choudhury, Deputy Secretary is present. However, she has also submitted a written statement dated 07.09.2021, which is taken into case records.
- 2. On perusal of the case records, it was noticed that the appellant has not enclosed the copy of the RTI petition and only copy of first appeal petition is enclosed in his second appeal petition before the Commission.
- 3. This second appeal petition without proper documents should not have been entertained at the Commission. However, since the case has come up for hearing and the SPIO as the Deputy Secretary has already provided the original RTI petition of Sri Ranjan Roy, which was forwarded to the Deputy Commissioner, Cachar for enquiry and necessary action, the Commission also feels that the course of action has to be initiated at the Office of the Deputy Commissioner, Cachar and therefore, directs the SPIO of the Department of Housing and Urban Affairs to transfer the RTI petition to the SPIO of the Deputy Commissioner, Cachar treating him as deemed SPIO, so that the information can be handed over by the Deputy Commissioner, Cachar.
- 4. With the above direction, the second appeal petition dated 8.3.2021 is disposed off.
