**O R D E R**  
14.9.2021

1. In continuation of this Commission's earlier order dated 20.8.2021, Sri Nabin Chandra Ingty, Dy. Director of Agriculture Department and Sri Bijoy Ch. Sarma, Deputy Director of Directorate of Agriculture are present. The petitioner Sri Joydeb Das is also present.
2. The DDA (ST&S) & SPIO of Directorate of Agriculture has submitted a statement dated 14.9.2021 which is taken into case records, wherein he has mentioned that actions has been initiated in compliance to the enquiry reported headed by Sri Jishnu Barua, Ex-Addl. Chief Secretary, Assam.
3. However, the appellant mentioned that neither the enquiry report of the Ex-Addl. Chief Secretary nor the details of the show cause notices as mentioned in the statement has been furnished to him.
4. Since, the RTI petition was addressed to the SPIO of the Chief Secretary, Assam and later forwarded to the Agriculture Department, the Commission therefore directs the SPIO of the Agriculture Department to furnish the information related to the show cause notice i.e. the numbers of seniors officers and numbers of junior officers to whom show cause notice are issued to the petitioner without mentioning the name, rank of the officer and number and date of the show cause notice.
5. With the above direction, the second appeal petition dated 02.07.2021 is disposed off.
