1. The petitioner Sri Dijendra Chandra Nath is present. The petitioner has filed his RTI application before the PIO of D.C.Darrang, Mangaldai on 23.6.2021.
2. The PIO of the Office of DC, Darrang, Mangaldai has sent a letter to the ADC, RKG Branch, DC's Office, Darrang, Mangaldai on 27.7.2021 to furnish the information to the appellant within stipulated time, as the matter was related to their department.
3. The petitioner then filed 1<sup>st</sup> appeal before the 1<sup>st</sup> Appellate Authority of the Office of D.C.Darrang, Mangaldai and then he filed 2<sup>nd</sup> appeal before the Commission on 6.9.2021. Accordingly, the matter was taken up for hearing.
4. The Public Authority to be represented by SPIO of the Office of Deputy Commissioner, Darrang, Mangaldai is absent without any intimation.
5. As reference to Commission's notice dated 5.10.2021, the SPIO was specifically asked to file a written statement if specific answer is given. In spite of that, the SPIO has failed to file any written statement.
6. The petitioner has intimated that only the appointment letter of Gaon Bura is furnished, but other points regarding copy of advertisement selection committee, copy of selected candidates, copy of appointment letter, copy of educational qualification, including mark sheet, admit cards etc of Gaon Bura are not enclosed.
7. The Commission directs the SPIO to furnish the remaining information within one month and submit an explanation for not filing any written statement before the Commission.
8. Fix another date of hearing.
