O R D E R
8/10/2021

1. The petitioner Alifar Rahman (on behalf of Golap Mazumdar) is present.
2. The petitioner has filed his RTI application before the SPIO, O/o the Deputy Commissioner, South Salmara, Mankachar on 7.1.2021 seeking information on officers as well as the beneficiaries who have been allotted land and also beneficiaries who were benefitted under erosion and flood damage scheme.
3. The RTI reply dated 2nd January 2021 could not be understood as how the Additional Deputy Commissioner, South Salmara Mankachar, Hatsingimari could write to the petitioner vide letter no. HRS-1/2016/213 dated Hatsingimari, 2nd January, 2021? asking him to deposit the cost of Xerox amounting to Rs 420.00 when the RTI petition was submitted on 7.1.2021.
4. The petitioner vide his letter dated 8.2.2021 mentioned that there was nobody to receive the cost of Xerox at the Office of Deputy Commissioner, South Salmara, Mankachar, Hatsingimari.
5. The petitioner then filed 1st appeal before the 1st Appellate Authority, O/o the Deputy Commissioner, South Salmara Mankachar, Hatsingimari on 23.2.2021 and then he filed 2nd appeal before the Commission on 20.4.2021. In his 2nd appeal, he has mentioned that on 11.2.2021 he has deposited the required fees through Electronic Money Order (EMO). Accordingly, the hearing was taken today.
6. The Public Authority to be represented by SPIO of the Office of District Commissioner, South Salmara, Assam is absent.
7. After going through the letters, the Commission directs the petitioner and the SPIO to fix a convenient date and provide necessary information and the whole process should be completed within one month from the date of receipt of this order.
8. In view of the above, the case is disposed off.
