<u>O R D E R</u> 4/10/2021

- The petitioner Syed Nazrul Islam is absent. The petitioner has filed his RTI Application before the PIO of Directorate of Food, Civil Supplies & Consumer Affairs on 4.5.2021 seeking details of information and answer scripts of the number of candidates appearing at the examination of Sub-Inspector post in the year 2008.
- 2. The SPIO in reply to the RTI application vide his letter dated 6.5.2021 mentioned that they are not in a position to furnish the information as a police case in connection with the recruitment of Sub-Inspector held on 2008, vide no. Bhangagarh PS C/No.09/18 has been registered and all the required documents are under custody of Bhangagarh Police Station.
- Inspite of that, the petitioner filed 1st appeal before the First Appellate Authority of Directorate of Food, Civil Supplies & Consumer Affairs on 28.6.2021
- 4. The SPIO of Directorate of Food, Civil Supplies & Consumer Affairs has sent a letter dated 30.6.2021 in reply to petitioner's 1st appeal petition wherein it is mentioned that the sought for information has already been provided to the petitioner through whatsapp, due to pandemic situation of Covid 19.
- 5. Then the petitioner filed 2nd appeal before the Commission on 19.8.2021 knowing fully well that this case cannot be adjudicated at the Commission level and the matter was taken up for hearing.
- 6. At the hearing, the Public Authority is represented by Sri Bhupen Chandra Baishya, SPIO cum Supdt. Directorate of FCS & CA, Bhangagarh
- 7. From the above, it is clear that the intention of the petitioner was not to get any information, but to waste the precious time of the Government Department and also the Information Commission.
- 8. Therefore, the Commission in disposing the case keeps a <u>copy of this order in</u> <u>record for future reference.</u>
