3. The Senior Planning Officer of the Office of DC, Nagaon sent the sought for information to the petitioner vide letter dated 27.1.2021.
4. On not being satisfied with the information, the petitioner filed 1st Appeal before the 1st Appellate Authority of DC, Nagaon on 2.4.2021.
