- 1. The petitioner Shahrukh Khan is present. The petitioner has filed his RTI application on 23.12.2020 before the Deputy Commissioner, Nagaon.
- 2. The Public Information Officer of the Office of Deputy Commissioner, Nagaon has transferred the RTI application to the District Development Commissioner, Nagaon on 5.1.2021 as the matter is related to their branch.
- 3. The Senior Planning Officer of the Office of DC, Nagaon sent the sought for information to the petitioner vide letter dated 27.1.2021.
- 4. On not being satisfied with the information, the petitioner filed 1st Appeal before the 1st Appellate Authority of DC, Nagaon on 2.4.2021.
- 5. The petitioner then filed 2nd appeal before the Commission on 19.8.2021 and accordingly the hearing was taken today.
- 6. The Public Authority is represented by Sanjib Kumar Thakur, Senior Planning Officer, D.C's Office, Nagaon (on verbal authorization of District Dev., Commissioner, Nagaon).
- 7. The Senior Planning Officer of D.C Nagaon has submitted a written statement vide no. NDC(RTI) 46/2016/340 dated 5.10.2021 which is taken into records.
- 8. The Commission accepts the written statement and Registry of this Commission is directed to give a copy of the written statement to the petitioner.
- 9. In view of the above, the case is disposed off.
