**6/10/2021**

1. The petitioner Habibar Rahman Khan is absent. The petitioner has filed his RTI application before the SPIO of the Office of Deputy Commissioner, Dhubri on 27.4.2021.
2. The SPIO of the Office of Deputy Commissioner, Dhubri transferred the RTI petition to the Additional Deputy Commissioner, Dhubri on 14.6.2021 as the matter was related to their department.
3. On non receipt of any information, the petitioner filed a complaint petition before the Commission on 9.8.2021 and accordingly the hearing was taken today.
4. The Public Authority to be represented by SPIO of the Office of Deputy Commissioner, Dhubri is absent without any intimation.
5. Sri Sudeep Banerjee (on behalf of Habibar Rahman Khan) has sent a mail before the Commission on 5.10.2021 wherein he has mentioned that the petitioner has received the sought for information from the SPIO of DC, Dhubri to his satisfaction.
6. However, the SPIO should have intimated the Commission on the fate of the RTI petition. His silence to the notice of the Commission on the hearing is not in conformity with the provision of the RTI Act and norms of the Commission.
7. In view of the above, the case is disposed off.
