O R D E R 30/09/2021

- 1. The petitioner Sri Joydeb Das is present. The petitioner has filed his RTI application on 12.4.2021 before the PIO of Chief Secretary's, Secretariat, Dispur 781006.On non receipt of any information, the petitioner filed 1st appeal before the First Appellate Authority of Chief Secretary, Dispur on 30.6.2021 and then he filled 2nd appeal before the Commission on 12.8.2021 and accordingly the matter was taken up for hearing today.
- The Public Authority was represented by Smti Dipali Devi, SPIO and Joint Secretary, Animal Husbandry & Veterinary Department and she is accompanied by Sri Abhijit Baruah, Secretary, AH & V Department and Sri Anjanabh Chaliha, Joint Secretary, AH & V Department.
- 3. In today's hearing, the appellant stated that he has received a letter vide no. VFV.84/2019/67 dated Dispur 21.8.2021 from the SPIO /Joint Secretary to the Govt. of Assam, Animal Husbandry & Veterinary Department wherein it is mentioned that the information can be given with the approval of the higher authority.

The SPIO also stated that process is on and the relevant information will be given shortly.

- 4. Therefore the Commission orders the SPIO to furnish the sought for information to the petitioner within a reasonable time after obtaining the approval of concerned higher authority.
- 5. In view of the above, the instant 2nd appeal petition dated 12.8.2021 is disposed off.
