**O R D E R**  
16.11.2021

1. The petitioner Sri Bipul Ch. Sarma is present. The public authority i.e. the SPIO of the Office of the Deputy Commissioner, Darrang is absent and has not submitted any written statement in pursuance to this Commission's notice SIC/DRN.45/2021/7 dated 28.10.2021.
2. The petitioner has filed RTI petition dated 3.11.2020 before the SPIO of the Office of the Deputy Commissioner, Darrang.
3. On not getting any information he filed first appeal petition dated 15.12.2020 before the First Appellate Authority. However, the First Appellate Authority heard the petition and no decision was taken except fixing new date on 13.7.2021 vide order No. DAN/RTI APPEAL-27/20-21/6 dated 25.6.2021.
4. In the mean time, the petitioner filed second appeal petition dated 14.9.2021 and accordingly the date of hearing is fixed today.
5. On perusal of the above, the Commission is of the opinion that the report as per Section 7(1) of the RTI Act, 2005 on the RTI petition as per Section 6(1) of the RTI Act, 2005 to be given by 30 days by the SPIO. The First Appellate Authority has 30 days to dispose the appeal.
6. In this case, enough time is lapsed on the part of the SPIO as well as the First Appellate Authority.  
Further, the SPIO is neither present nor has submitted any written statement on the disposal of the RTI petition.
7. The SPIO of the Office of the Deputy Commission, Darrang has failed to comply the provisions of the RTI Act, 2005. This is a fit case to impose penalty for his failure to furnish the information within the stipulated time period.
8. However, before imposing the penalty, the Commission would like to hear the explanation of the SPIO and the same should be furnished within 15 days from the date of receipt of this order and after that the decision will be taken by the Commission.
