**O R D E R**  
16.11.2021

1. The petitioner has filed RTI petition dated 08.07.2021 before the SPIO, O/o the Chief Engineer, PWD (Roads). The SPIO, O/o the Chief Engineer has forwarded the RTI petition to the Additional Chief Engineer, PWD, Kokrajhar to take necessary action vide letter No. CE/RTI/32/2018/42 dated 13.07.2021.
2. Reportedly on not getting any information, the petitioner filed first appeal petition dated 3.9.2021 before the First Appellate Authority of the Office Chief Engineer, PWD (Roads). Then the petitioner filed second appeal petition dated 4.10.2021 before the Commission. Accordingly the date of hearing of second appeal petition is fixed today.
3. The petitioner Sri Bhaskar Jyoti Das is present. The public authority i.e. the SPIO of the Office of the Chief Engineer Sri K. Bayan and Sri Khanin Ch. Boro are present. The SPIO of the Office of the Chief Engineer, PWD (Roads) has submitted a written statement which is taken into case records.
4. In the written statement he has mentioned that the information as available in their office has already furnished to the petitioner. However, some information related to the third party. Under Section 11 of the RTI Act, 2005 they have already communicated with the 3<sup>rd</sup> party.
5. Since, they have already communicated with the concerned third party for information and has not received any reply, the SPIO is advised to send a reminder to the so called 3<sup>rd</sup> party and after the expiry of the reminder the SPIO has to take a decision on furnishing the information to the petitioner.

The case is disposed off.
