1. The petitioner has filed RTI petition dated 15.7.2021 before the SPIO, O/o the Deputy Commissioner, Kamrup(M) seeking following information

- (i) Please furnish documents submitted by Sri Indrajit Barman, S/o Sri Gunindra Barman belongs to "Saloi" caste prior issuance of OBC certificate issued by All Assam Other Backward Classes' Association and counter signature by Assistant Commissioner, Kamrup Metropolitan District dated 30.5.2017 (copy enclosed) along with copy of all file noting of officials/officers regarding issuance the OBC certificate

2. Reportedly on not getting information the petitioner filed first appeal petition dated 7.9.2021 before the First Appellate Authority of Deputy Commissioner, Kamrup(M). Then the petitioner filed second appeal petition dated 16.10.2021 before the Commission. Accordingly the date of hearing is fixed today.

3. The petitioner Sri Joydeb Das is present. The public authority i.e. the SPIO of the Office of the Deputy Commissioner, Kamrup(M) Sri Munindra Bordoloi, ADC, Kamrup (M) is also present. He has also submitted a written statement dated 20.11.2021 which is taken into case records.

4. In the written statement it has been mentioned that the Addl. Deputy Commissioner, Adiminstration Branch, Kamrup (M) requested the Principal/General Secretary, All Assam OBC Association to submit the related documents regarding issuance of OBC certificate to Sri Indrajit Barman vide letter No. KAV.09/2021/588-89 dated 03.08.2021. But no reply has been received till now.

5. In light of it, the Commission directs the SPIO, O/o the Deputy Commissioner, Kamrup(M) to submit specific reply to the petitioner within 15 days from the date of receipt of this order.

6. The second appeal petition dated 16.10.2021 is disposed off.
