O R D E R 06/12/2021

- The petitioner Sri Harinarayan Pathak has filed his RTI application before the SPIO, Assam Industrial Infrastructure Development Corporation on 16.1.2021 seeking information relating to copy of Public Documents and inspection of files of A.I.I.D.C..
- 2. The SPIO of the office of A.I.I.D.C, vide letter no. AIIDC/3106/2021/1512 dated 12.2.2021 issued a letter to the petitioner to deposit an amount in favour of AIIDC towards the cost of furnishing the information.
- 3. In receipt of that, the petitioner deposited the necessary amount and submits another petition dated 26.2.2021 before the SPIO of the Office of AIIDC for inspection of records.
- 4. In the meantime, he submitted 1st appeal before the 1st Appellate Authority of AIIDC on 22.6.2021 for expediting submitting of information.
- 5. In due course, the petitioner submitted 2nd appeal petition before the Commission on 16.10.2021 and accordingly the matter was taken up for hearing.
- 6. The petitioner Sri Harinarayan Pathak is absent. However, he has sent an application dated 6.12.2021 wherein he has mentioned that due to his eye problem he is unable to attend today's hearing.
- 7. The Public Authority is represented by Sri Ritumoni Pachani, General Manager & SPIO, A.I.I.D.C.
- 8. The SPIO, AIIDC & General Manager (Civil), AIIDC, IE, Bamunimaidam has submitted a written statement vide no. AIIDC/3106/2021/2422 dated 4.12.2021 which is taken into records. In the written statement, it is mentioned that sought for information has already been furnished to the petitioner vide letter no. AIIDC/3106/2021/2401(B) dated 29.11.2021.
- 9. Since the information is furnished, the instant 2nd appeal petition dated 16.10.2021 is disposed off.
