O R D E R 18/11/2021

- 1. The petitioner Sri Joydeb Das is present. The petitioner has filed his RTI application before the PIO of Gauhati University on 12.4.2021 seeking some information regarding "Uttaran Trust". On non-receipt of any information, the petitioner filed 1st appeal before the First Appellate Authority of Gauhati University, Jalukbari on 21.6.2021. Then the petitioner filed his 2nd appeal before the Commission on 30.7.2021 and accordingly the matter was taken up for hearing.
- 2. The Public Authority is represented by Dr. Prasanta Barman, Deputy Registrar and PIO, Gauhati University. He is accompanied by Dr. Mukul Chakravarty, Trustee, Uttaran Trust, Bhitarkhola. The PIO of Gauhati University has submitted a written statement dated 12.11.2021 which is taken into records.
- 3. <u>Information relating to point no.1</u> The Deemed PIO has mentioned that the Managing Committee is not yet formed. So they are not in a position to furnish the information. The petitioner then intimated that he has not yet received the registration copy, to which the Deemed PIO mentioned that they do not have registration copy and replied to treat Trust Deed as the registration copy. Further the petitioner mentioned that the copy is not legible.

The Commission directs the petitioner to visit the Office of PIO/Deemed PIO and collect legible copies. The PIO/Deemed PIO to handover without any delay.

4. <u>Information relating to point no.2</u> – The petitioner has mentioned that copy supplied of aims and objectives is illegible and not clear on aims and objectives, to which the deemed PIO has mentioned that aims and objectives are the bye – laws of trust.

The Commission directs the deemed PIO to provide legible copies of aims and objectives to the petitioner, and the copies and objectives will be treated as bye laws as intimated by the deemed PIO.

5. <u>Information relating to point no. 3</u> – The petitioner has mentioned that details of land area and location of land is given, but the details of assets and liabilities is not yet furnished.

To which the Deemed PIO intimated that he has got the copy of details of assets and liabilities and the same will be given to the petitioner today itself.

In view of the above, the case is disposed off. Authenticated copies to be given to all concerned.
