**O R D E R**  
**18/11/2021**

1. The petitioner Sri Joydeb Das is present. The petitioner has filed his RTI application before the PIO of Gauhati University on 18.2.2021 seeking following information:  
(a) Please furnish Car diary and Tour Diary along with copies of TA Bill for old car and present car allotted to officers from 2018 till date.
2. On not being satisfied with the information furnished by Gauhati University, the petitioner filed 1<sup>st</sup> appeal before the First Appellate Authority of Gauhati University on 31.8.2021 wherein it was mentioned to furnish the copies of the Car diary and TA Bill at the earliest.
3. And then the petitioner filed 2<sup>nd</sup> appeal before the Commission on 30.9.2021. Accordingly the matter was taken up for hearing.
4. The Public Authority is represented by Dr. Prasanta Barman, Deputy Registrar and PIO, Gauhati University. The PIO of Gauhati University has submitted a written statement dated 12.11.2021 which is taken into records.
5. In the hearing, the petitioner said that he has got the copies of Car Diary and Tour Diary, but copy of TA Bill has not been furnished to him.
6. After hearing the statements of both the parties, the Commission directs the SPIO to furnish the details of all the TA Bills of the officers using both the old allotted and presently allotted car, to the petitioner within 30 days from the date of receipt of this letter.
7. The case is disposed off.
