## RDER18/11/2021

- 1. The petitioner Sri Joydeb Das is present. The petitioner has filed his RTI application on 25.5.2021 seeking some information of M/s Ragini Oil Traders, Tezpur. On non receipt of any information, the petitioner filed 1st appeal before the First Appellate Authority of the Office of Deputy Commissioner, Tezpur on 15.7.2021. After that the petitioner has filed a complaint petition on 19.8.2021 before the Office of the Deputy Commissioner, Tezpur.
- 2. The petitioner then filed a 2<sup>nd</sup> appeal before the Commission on 5.10.2021 and accordingly the matter was taken up for hearing.
- 3. The Public Authority is represented by Smti. Kabita Phangcho, ACS, SPIO, DC Office, Sonitpur and she is accompanied by Muzibudin Ahmed, Superintendent, FCS & CA, Sonitpur.
- 4. The First Appellate Authority of the Office of Deputy Commissioner, Tezpur has submitted a written statement dated 16.11.2021 which is taken into records.
- 5. At the outset, the petitioner said that some copies furnished to him were not legible. But in the meantime, he has got the information (legible copies) but reply to his petition question no.1(a) and no 1(b) are not given i.e., 1(a) copy of guidelines for issuance of selling license and storage license and 1(b) Has the M/s Ragini Oil Traders submitted valid explosive license, copy of insurance of staff and NOC from competent authority and locality for storage of Subsidized kerosene oil prior issuance of Deputy Commissioner, Sonitpur selling license and storage license of Subsidized Kerosene Oil.
- 6. Muzibudin Ahmed, Superintendent of FCS & CA, Sonitpur has verbally intimated that he has recently been posted and he will trace out the documents and will provide it to petitioner.
- 7. The Commission orders that within fifteen days from the receipt of this letter the Superintendent should directly send the information as available to the petitioner through registered post.
- 8. The case is disposed off.
